CONSENT AGREEMENT AND ORDER

The Commonwealth of Pennsylvania, Bureau of Charitable Organizations ("Bureau") and Hale House Center, Inc., ("Respondent") stipulate as follows in settlement of the abovecaptioned case:

JURISDICTION

- This matter is before the Secretary of the Commonwealth ("Secretary") pursuant to the Solicitation of Funds for Charitable Purposes Act ("the Act"), Act of December 19, 1990, P.L. 1200, No. 202, as amended, 10 P.S. §§162.1-162.24.
- Respondent was registered with the Bureau as a charitable organization in the 2. Commonwealth of Pennsylvania from January 7, 1994, to November 12, 2001, registration number 12291.
- 3. At all relevant and material times to the Stipulated Facts contained herein, Respondent was not registered as a charitable organization with the Commonwealth of Pennsylvania.

STIPULATED FACTS

4. Respondent admits the following facts are true:

- a. Respondent's last known business address on file with the Bureau is 152 West 122nd Street, New York, NY 10027.
- b. Respondent unintentionally solicited charitable contributions in Pennsylvania after its registration expired on November 12, 2001.

MITIGATION

- 5. Respondent states the following in mitigation of the foregoing facts:
- a. Respondent took reasonable steps to inform its direct mail fundraising counsel that all solicitations into Pennsylvania after the expiration of Respondent's registration were to cease until Respondent had become fully registered in Pennsylvania to conduct charitable solicitations.
- b. Any mailings or materials sent directly by Respondent to citizens of Pennsylvania after the expiration of its registration did not include a solicitation for contributions and thus were not sent in violation of the Act.

AGREED VIOLATIONS

6. Respondent agrees that by engaging in the foregoing activities it violated the Act at 10 P.S. § 162.15(a)(1) by unintentionally soliciting charitable contributions in the Commonwealth of Pennsylvania after its registration expired

<u>PROPOSID ORDER</u>

- 7. The parties consent to the issuance of the following Order in settlement of this matter:
 - e. Respondent violated the Act at 10 P.S. §162.15(a)(1).
 - b. An ADMINISTRATIVE FINE of one thousand dollars (\$1,000.00) is .

 levied upon Respondent. Respondent shall tender the full sum of one thousand dollars.

(\$1,000.00) with this executed Consent Agreement which shall be paid by certified check, cashier's check, attorney's check, or U.S. Postal money order made payable to the "Commonwealth of Pennsylvania."

- c. An ASSESSMENT FOR THE COSTS OF INVESTIGATION of one thousand dollars (\$1,000.00) is levied upon Respondent. Respondent shall tender the full sum of one thousand dollars (\$1,000.00) with this executed Consent Agreement which shall be paid by certified check, cashier's check, attorney's check, or U.S. Postal money order made payable to the "Commonwealth of Pennsylvania."
- d. Within ten (10) days of the signing of this Consent Agreement,

 Respondent shall file with the Bureau an amended Form 990 appropriately addressing all
 the concerns outlined in the Bureau's September 30, 2003, letter from the undersigned
 prosecuting attorney.
- f. Respondent shall, at all times, maintain true and accurate records so that statutorily required audits can be performed each year.

VIOLATION OF THE SECRETARY'S ORDER

- g. Notification of a violation of the terms and conditions of this Consent

 Agreement and Order shall result in the imposition of additional penalties as follows:
 - (1) The prosecuting attorney for the Bureau shall file with the Secretary a Petition which indicates that Respondent has violated the terms and conditions of this Consent Agreement and Order.
 - (2) Upon a probable cause determination that Respondent has violated the terms and conditions of this Consent Agreement and Order, the Secretary, or his designes, shall, without holding a formal hearing, issue a Preliminary Order,

offective thirty (30) days after its mailing, which imposes a sixty (60) day period of suspension on Respondent's registration to act as a professional solicitor.

- (3) Respondent shall be notified of the Preliminary Order within three (3) days of its issuance by certified mail and first class mail postage prepaid, sent to the last registered address on file with the Bureau by facsimile or first class mail.
- (4) Within fifteen (15) days of mailing of the notification of the Preliminary Order, Respondent may answer the Commonwealth's petition, request that a formal hearing be convened concerning Respondent's alleged violation of the terms of this Agreement, and move that the period of suspension be stayed until the Secretary or his designee issues a final order. Respondent shall file all answers and subsequent filings with the Prothonotary for the Department of State, 2601 North Third Street, Harrisburg, PA 17110. Respondent shall serve the prosecuting attorney for the Bureau with a copy of the answer and all subsequent filings in this matter.
- (5) If the Respondent moves for a stay of the period of suspension, Respondent shall set forth properly verified facts and/or state concisely the matter of law which the Respondent believes justifies a stay of the period of suspension. The Secretary or his designee shall issue a ruling on the Respondent's motion within fifteen (15) days from the date of the mailing of the notification of the Preliminary Order. If the Secretary or his designee makes no ruling on the Respondent's motion within the fifteen (15) days from mailing of the notification of the Preliminary Order, the Respondent's motion shall be deemed denied.

- (6) If a request for a formal hearing is received from Respondent, a formal hearing shall be convened within forty-five (45) days from the date of filing of Respondent's request for a formal hearing.
- (7) The facts and averments in this Consent Agreement and Order shall be deemed admitted and uncontested at this hearing.
- (5) If the Secretary, or his designee, after such hearing makes a determination adverse to Respondent, the Secretary or his designee will issue a Final Order imposing any disciplinary measures he deems appropriate. The Secretary or his designee may, but is not required to, take into account any period of active suspension already served by the Respondent pursuant to the Preliminary Order.
- (9) If a request for a formal hearing is not received from Respondent within the prescribed fifteen (15) day period, the Preliminary Order shall become a Final Order.
- the Bureau from filing charges or the Secretary from imposing disciplinary or corrective measures for violations or facts not contained in this Consent Agreement; provided, however, the Bureau agrees to not re-open its investigation with regard to any Registration Statements or Contracts on file with the Secretary as of the date of this Consent Agreement and Order unless the Bureau becomes aware of material facts or omission of material facts which have previously not been disclosed to it and would give it probable cause that other violations existed during such period of time which it failed to uncover in its previous investigation.

h. This case shall be deemed settled and discontinued upon the Secretary issuing an Order adopting this Consent Agreement.

ACKNOWLEDGEMENT OF NOTICE AND WAIVER OF HEARING

Respondent waives the filing of an Order to Show Cause in this matter.

Respondent knowingly and voluntarily waives the right to an administrative hearing in this matter, and to the following rights related to that hearing: to be represented by counsel at the hearing; to present witnesses and testimony in defense or in mitigation of any sanction that may be imposed for a violation; to cross-examine witnesses and to challenge evidence presented by the Bureau; to present legal arguments by means of a brief; and to take an appeal from any final adverse decision.

<u>AGREEMENT NOT BINDING ON OTHER PARTIES</u>

9. This Consent Agreement is between the Bureau and Respondent only. It does not bind any other administrative entity of the Commonwealth of Pennsylvania, including any other bureau within the Department of State. Except as otherwise noted, this Agreement is to have no legal effect if a) the Office of General Counsel expresses an objection to the Agreement's form or legality and/or b) unless and until the Secretary issues the stipulated Order.

EFFECT OF SECRETARY'S REJECTION

10. Should the Secretary not approve this Consent Agreement, presentation to and consideration of this Consent Agreement and other documents and matters by the Secretary shall not prejudice the Secretary from further participation in the adjudication of this matter. This paragraph is binding on the participants even if the Secretary does not approve this Consent Agreement.

ENTIRE AGREEMENT

11. This Agreement contains the whole agreement between the parties; provided, however, that the captions printed in the various provisions of this agreement are for ease of reading only and are not to be interpreted as forming any part of this agreement. There are no other terms, obligations, covenants, representations, statements or conditions, or otherwise, of any kind whatsoever, concerning this Agreement.

ACREEMENT DOES NOT PREVENT REFERRAL TO OTHER AGENCIES

12. The parties acknowledge that other federal, state, and/or local agencies may have jurisdiction over the activities of, or representations made by, Respondent and its officers, directors, agents, employees or independent contractors. Nothing in this Consent Agreement or the Order based upon this Consent Agreement shall preclude representatives of the Bureau from referring any information or data produced as a result of this matter to any federal, state, or local agency or governmental unit having jurisdiction over the activities of Respondent or any officer, director, agent, employee or independent contractor of the Respondent.

VERIFICATION OF FACTS AND STATEMENTS

13. Respondent verifies that the facts and statements set forth in this Agreement are true and correct to the best of Respondent's knowledge, information and belief. Respondent understands that statements in this Agreement are made subject to the criminal penalties of 18 Pa.C.S. §4904 relating to unsworn falsification to authorities.
